It is recommended that in the future, crew personal items brought onboard the Shuttle be documented and concurred on by applicable personnel (Safety, etc.) during real-time. Attempts to get these lists prior to STS-71 failed and even though the Russians requested these lists in joint working group meetings, the request was never relayed to MCC-H by MCC-M and MCC-H would not request in real-time unless they had a formal Russian request.


