





This does not include an institution's own graduates who re-enter for further education. This variable does include graduate students who are accepted into a master's or doctoral program for the first time. A "No" for this variable would indicate a continuing or returning student.

³ Residency represents the county, state, or foreign country of which the student is a resident as identified by the student as his/her permanent address at the time of application to the institution. This variable should not be used to identify how students are actually charged tuition as other factors are involved in that determination.

Total UHCL Ethnicity: Fall 2012




Figure 2: Total UHCL Undergraduate







Total UHCL Undergraduate Ethnicity: Fall 2012




Figure 3: Total UHCL Graduate





Total UHCL Graduate Ethnicity: Fall 2012













Total BUS Undergraduate Ethnicity: Fall 2012




Figure 6: Total School of Business (BUS) Graduate









Total HSH Ethnicity: Fall 2012




Figure 8: Total School of Human Sciences and Humanities (HSH) Undergraduate






Total HSH Undergraduate Ethnicity: Fall 2008







Total HSH Graduate Ethnicity: Fall 2012




Figure 10: Total School of Science and Computer Engineering (SCE) N = Actual number of cases; % = Column percent; n/a = not applicable








Figure 11: Total School of Science and Computer Engineering (SCE) Undergraduate







Total SCE Undergraduate Ethnicity: Fall 2012




Figure 12: Total School of Science and Computer Engineering (SCE) Graduate







Total SCE Graduate Ethnicity: Fall 2012




Figure 13: Total School of Education (SOE) N = Actual number of cases; % = Column percent; n/a = not applicable







Total SOE Ethnicity: Fall 2012




Figure 14: Total School of Education (SOE) Undergraduate






Total SOE Undergraduate Ethnicity: Fall 2008





Total SOE Undergraduate Ethnicity: Fall 2012









Total SOE Graduate Ethnicity: Fall 2012




Figure 16: Total UHCL Undeclared Majors (UND)








	Figure 17: Data Definitions Query used = PEGGY_UHCB_001_ONLY
