Harris, in the State of Texas, for and in consideration of the sum of Four Hundred Ninety-Eight and 75/100 (\$498.75) Dollars to me in hand paid by the State of Texas acting through the State Highway Commission receipt of which ishereby acknowledged, have this day sold, and do by these presents grant, bargain, sell and convey, unto the State of Texas all that certain tract or parcel of land situated in the County of Harris, State of Texas, and being part of a survey originally granted to Ritson Morris by Patent No. 703, Volume 8, Abstract #52, and being more particularly described as follows, to-wit:

Being a strip of land 100 feet wide, containing 14,497 sq. ft., over and across the N rthwest 1/2 of Block 28, of Seabrook a subdivision situated in the Ritson M rris Survey, Abstract #52, in Harris County, Texas. Plat of said subdivision is duly recorded in Volume #1, Page 50, Harris County Map Records, reference to which is hereby made. Said 14,497 sq. ft, being more particularly described as follows:

THENCE NORTH 40° 39' East, along the Northwest line of Block 28, and the Southeast line of Anders Srteet, a distance of 135.3 feet to a stake that is 50 feet Easterly, at right angles, from the proposed center line of State Highway No. 146, or the Seabrook Loop Road and 175 feet Easterly at right angles, from the said center line of the G.
