City Events

OCTOBER, 1965

First Mortgage Company of Houston has announced a new \$15 million development in Clear Lake City. Located on Kirby Road, the heavily-wooded 165 acre tract will be divided into approximately 500 lots with luxury homes in the \$27,000 to \$35,000 price range. Ground breaking on the first section of lots is expected after the first of the year. Clear Lake Forest will offer recreational facilities, Country Club memberships and golf course facilities to residents.

Glen Norwood has announced a new Medical-Dental clinic for Clear Lake City to be located on Sealark Lane and Clear Lake City Boulevard. Construction will begin in approximately thirty days, with completion expected early in 1966. The first phase will have two dental and three medical suites. Phase two, a four unit building, is scheduled for construction later in 1966.

The "New Orleans Trip" contest was such a success that Friendswood Homes is sponsoring the contest again. This time the prize is \$500. The Bay Area Chorus is currently meeting each Sunday night at 8:00 PM in the Community Recreation Center. The Chorus, known for last year's excellent performance of Handel's "Messiah", is preparing for this year's program.

The Melody Lane Music Store recently opened in Camino South Shopping Center. Music lessons, instruments, sheet music, and records are available. Other new tenants include the Yum-Yum Tree Gift Shop and Sanborn's Travel Agency, both of which are expected to open in November.

Three new aero-space firms occupied space in the Alpha Building in September: Federal Electric Corporation, Informatics, Inc., and Univac, a Division of Sperry Rand Corporation.

Work has begun on Centaur, the third building in the Gemini office complex. Building number 1, Vanguard, has already been partially leased by Federal Electric Corporation and Friendswood Development Company. Nova, building number 2, has been leased entirely by IBM.

A Trade Association was recently formed by Clear Lake City Merchants to promote the Camino South and Quick Service Shopping Centers. The Association's Board of Directors is composed of five members: Bob Sorrels, Walgreen's, Ron McCall, T. G. & Y., John Mazor, Coffee Cove, P. A. Watson, Camino South Barber Shop, and Harold Nordstrom of the NASA Grill.

A second resident deputy sheriff has been assigned to the Seabrook-Clear Lake area, and will work much of the time in Clear Lake City.

Civic League

The October 21st meeting of the Civic League featured Dr. Gerald Barber, Superintendent of the Clear Creek School District. Dr. Barber discussed several topics, including the communities new 19-classroom elementary school. He also expressed his appreciation to the people of Clear Lake City for their cooperation during the time temporary classrooms were used.

The Clear Creek School District will soon be keeping the high school library open three nights a week. A librarian, mathematics, and an English teacher will be on duty to assist students. This is another step to provide students enrolled in the Clear Creek system with the best possible educational opportunity.

To quote Dr. Barber, "The Clear Creek School District is the most unique school system in the country" due to its rapid growth over the last few years. In 1962, there were approximately 2,500 students in the district. By September 30th of this year, 5,363 students were enrolled. Projections indicate that almost 35,000 students will be enrolled at the end of 1970.

The Clear Lake City Civic League is now officially incorporated under the laws of Texas as a non-profit corporation. The necessary papers were turned over to Paul Mayer Thursday night.

Rec Center

A strange complaint was recently received by the Rec Center Staff -- it seems there are too many activities to choose from! Some Clear Lake City residents wanted to enroll in all the activities, not just one or two. Currently the Center offers bridge classes, tin flower making, dancing, judo, art, and the Great Books Discussion Group, not to mention ladies' exercise and volleyball, and men's exercise and volleyball. But the present line-up is only the beginning. After the first of the year many new programs will be offered to interested residents.

The Basketball season is now upon us, and all boys interested in joining a team for league play are asked to report to the Gym on Wednesday, November 10th, at 7:00 PM., ready to play. Three teams will be organized: Boys 12 and under, 13 to 14, and 15 to 18. The open age men's team has already been organized and practices Monday and Wednesday nights. Spots are still open for any resident men wishing to play. Coaches are still needed for the boys teams, and if you would like to coach please call the Center.

On Tuesday, November 9th, at 7:30 PM the Advisory Committee will hold its November meeting. The main order of business will be a report from the Nominating Committee, announcing three nominees who have agreed to seek election in December to the Advisory Committee. Nominations will also be accepted from the floor. As stated in the By-Laws "The Advisory Committee of the Clear Lake City Recreation Center shall be composed of five members, each of who shall be Sui-Juris, be over the age of twenty-one years, shall have been a resident of Clear Lake City for at least six months and shall not have been a member of the Committee at any time within one year preceding the date of his or her election".

Freeman Library

The Freeman Memorial Library, in order to better serve the citizens of the Clear Lake area, has chosen to withdraw from the Harris County Library system. In the future, library cards from both Harris and Galveston Counties will be honored, but the library will remain an independent concern.

In the move, a large volume of books will be returned to Harris County. If you have books you would like to donate, contact Mrs. Betty Ulrich, librarian, at HU 8-2330.

New shelves were recently installed and volunteer workers continue to sell business and family Christmas cards, with proceeds going to the library.

November 20th through the 24th a Book Fair will be held at the Webster Civic Center from 10:00 AM to 9:00 PM daily, with a large selection of books for sale by Foley's. In connection with the fair, Leon Hale, columnist for the Houston Post, will be on hand at 7:00 PM, November 22nd, for an Autograph Party.
