













Total BUS Ethnicity: Spring 2013












Total HSH Ethnicity: Spring 2013





Total HSH Undergraduate Ethnicity: Spring 2013










Total SCE Ethnicity: Spring 2009



Total SCE Ethnicity: Spring 2013





Total SCE Undergraduate Ethnicity: Spring 2013





















Total SOE Undergraduate Ethnicity: Spring 2013
















	Figure 17: Data Definitions Query used = PEGGY_UHCB_001_ONLY
