## City Events

JANUARY, 1966

Three new Directors of the Clear Lake City Water Authority were elected January 11th for two year terms. In position one Jim Eardley, an engineer with General Electric, was elected. Bob Dare, manager of the Haden Facility in Seabrook, won re-election in position two. In position three, Gloria Goldstein replaced Tom McElhinney. The Board's new officers are: President, Henry Montz, Vice-President, Jim Eardley, and Secretary, Theo Pound.

The Harris County Sheriff's Department has assigned Gus Wolf as a full time deputy in Clear Lake City effective February 1st. His prime responsibility will be law enforcement matters in our area. Wolf had more than ten years service with the Department of Public Safety before joining the Sheriff's Department. February 1st the services of Burn's International Detective Agency were discontinued (except for the commercial foot patrol) due to the regular presence of a Harris County Deputy Sheriff. The new phone number for a law enforcement officer is CA 8-8311, extension 212.

Norwood Homes will soon begin construction of 48 townhouses on Ramada Drive, backing up on the golf course. The gross value of phase one is more than \$1 million. The new townhouses will range from \$16,950 to \$24,000, have 1300 to 1700 square feet and condominium financing, and be completely maintenance free to the owner. Completion is expected in late spring.

## Civic League

The new Officers and Directors of the Civic League were installed at the regular bi-monthly meeting January 20th. Bob Duffy, in his remarks, stressed the need for the League to be a guiding influence in the community. He stated that the League should concern itself with the more important problems of the community, and spend less time dealing with insignificant matters that could best be handled by an individual homeowner.....such as a stray dog.

Effective February 1st a full time Sheriff's deputy will work in Clear Lake City, providing adequate protection against traffic violators and handling other law enforcement problems. Gus Wolf, the new deputy, will be part of a team providing 24-hour police protection for Clear Lake City. "The continued presence in our development of an officer of this agency (Harris County Sheriff's Department) will be another contribution toward making Clear Lake City an outstanding community", said Norm Shirley, Vice President of the Clear Lake City Community Association in a recent letter to the Civic League. In the future, any person desiring contract with a law enforcement officer should call CA 8-8311, Ext. 212.

Soon members of the Civic League will begin a full scale membership drive in the community. For additional information, or to volunteer your help, call Bob Duffy, HU 8-0237. Duffy has also asked that you call him, or a member of the Board, if you have any problems that the Civic League might be able to help solve.

## Rec Center

Due to space limitations and the physical nature of the small Rec Center nursery, it can not accept any school age (includes kindergarten) children. The nursery now serves an average of 35 pre-school age children during peak periods. The addition of any kindergarten age children would pose too large a burden on the two nursery attendants.

Presently, the Rec Center Advisory Committee and the Director are studying a number of possible summer programs which will be attractive and rewarding to the largest number of Clear Lake City youngsters possible. Definite plans are being formulated and will be discussed at the March 8th meeting of the Advisory Committee. All CLC residents are invited.

Three Dancing classes (all adults) are now meeting Tuesday and Wednesday nights at the Rec Center, plus a four-table bridge group, and a military class on Tuesday mornings. A tin flower class, judo, basketball, ladies exercise class on Tuesday and Thursday mornings, a session on Personality and Poise for Junior and Senior high school girls, and a class in Baton Twirling are now in progress at the Center.

As a reminder, the Rec Center is open for use by all residents of CLC and their guests. However to control non-resident usage, the following requirements are followed:

1. Guests must secure a guest badge at the business office.
2. Guests seventeen and under must be accompanied by a resident and resident members seventeen and under may bring one guest per day.
3. Guests shall pay 25¢ per child seventeen and under. Adults 50¢ per visit.
4. Residents with house guests may check out badges good for the length of visit. A fee of \$1.50 per family per week is required.

## Freeman Library

Some time ago Martin Gracey, treasurer of the Library's Board of Trustees, was asked to secure company and industrial support for the library. Since then, Graham Engineering has given \$1000, Klate Holt has donated \$1000, and it looks as though a number of other companies will follow their example.

The former Mrs. Faith Freeman recently donated \$2000 worth of furniture to the library, including tables, chairs, stacks, magazine shelves, book trucks, a study carrel, and card catalogue. The furniture has arrived and been installed.

Presently the library has more than 3500 volumns and serves a school district with a population of 28,500. National statistics indicate a library for a population this size should have 57,000 books, or two per person. The Freeman Library is among the most unique in the world; receiving no tax aid, it is a product of donations and many communities working together toward a common goal - - a storehouse of knowledge for themselves and their children. We have come a long way from nowhere - but still have a long way to go. With your help we'll make it.
